- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **18 separate freshwater wetlands were determined to be isolated, non-jurisdictional within the total project area of 234.79 acres. This parcel is a portion of a large parcel covered under the still active JD SAC-2014-00462. These wetlands were determined to be surrounded by upland soils with no hydrologic connection of any kind to any OHWM/MHW of any waters of the U.S. The 18 isolated, non-jurisdictional wetlands located within the project area meet the parameters that define a wetland outlined in the 1987 Wetland Delineation Manual; however, these wetlands were determined not to be adjacent to any waters of the United States. In addition, the project area contains numerous upland excavated non-jurisdictional ditches that were determined to drain only uplands. None of these non-jurisdictional ditches are in close proximity to the 18 wetlands documented as isolated, non-jurisdictional on this basis form. The still active previous determination's site visit was conducted under normal climatic conditions where rainfall has been documented as normal for the previous 3 months prior to the onsite visit.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

These wetlands were determined to be surrounded by upland soils with no hydrologic connection of any kind to any OHWM/MHW of any waters of the U.S. The 18 isolated, non-jurisdictional wetlands located within the project area meet the parameters that define a wetland outlined in the 1987 Wetland Delineation Manual; however, these wetlands were determined not to be adjacent to any waters of the United States. In addition, the project area contains numerous upland excavated non-jurisdictional ditches that were determined to drain only uplands. None of these non-jurisdictional ditches are in close proximity to the 18 wetlands documented as isolated, non-jurisdictional on this basis form. C. SIGNIFICANT NEXUS DETERMINATION
