- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The project area contains potential wetlands; however, the potential wetland areas lack two of the parameters that define a wetland outlined in the Corps' 1987 Wetland Delineation Manual. The project area lacks the parameters of Hydrology and Hydric Soils. The data sheets submitted by Brigman, dated May 1, 2019, document no indicators of Hydrology and indicate the soils (sandy soils) consists of at least 30 percent uncoated sand grains, therefore, not meeting any of the Hydric Soil Indicators. Horry NWI maps supports this determination by mapping the site as forested wetlands partially ditched/draind.**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
