Explain: **Onsite within the project area is a non-jurisdictional upland excavated pond. This pond was determined not to be an impoundment of waters of the US. In addition, the project area contains potential wetland areas. These areas lack all three parameters that define a wetland as outlined in the Corps' 1987 Wetland Delineation Manual and/or Regional Supplement. The specific parameters not met by review of the submitted data sheets provided by S&ME are Hydric soils and Hydrology. Soils were documented by S&ME as being greater than 30% uncoated sand grains visible and no hydrology or indicators of hydrology being present. This documentation is provided in the data forms dated 23 May 2019.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is surrounded entirely by public access improved roads. Located onsite is an upland excavated non-jurisdictional pond/ borrow area. Site contains potential wetland areas; however, it was determined by review of the submitted data sheets dated 23 May 2019, all three parameters that define a wetland are not present (see Section B.2. of this document). The site was determined to comprised entirely of uplands by review of all available desktop resources and S&ME's JD request package dated May 23, 2017. A site visit was not performed.
