connections to waters of the U.S. In addition to utilizing remote resource tools (to include LDIAR, USGS Topographic Map, USDA Soil Survey Map, and Infra-red aerial photography) a field inspection was completed. The wetland is situated in a depression pocket within the landscape and is surrounded up uplands. In addition, the wetland has no apparent physical, chemical, or biological connection to waters of the U.S., and has no connection to interstate or foreign commerce.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

holding water (open water) during the site visit but there were no signs of hydrologic flow in the ditches and the ditches did not exhibit tributary features such as sediment sorting or relatively permanent flow. These ditches do not show up as blue line tributaries on historical USGS topographic maps and are not located in wetlands. Therefore, these ditches appear to have been constructed in the uplands at a depth and gradient that facilitates retaining open water. Therefore, the ditches are considered non-jurisdictional and not subject to regulation under the Clean Water Act.

The channel was observed as being approximately 2 feet wide and 1 feet deep on site. The perennial RPW is identified as a blue line stream on the USGS topographic map. The perennial RPW appears to receive hydrology from its upstream reach flowing into the site from the eastern boundary, the abutting wetlands onsite, ground water, and precipitation. For the above reasons the stream channel was determined to have perennial flow. This perennial RPW flows into Popperdam Creek flows which flows into the Ashley River (a tidally influenced TNW).
