- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **There is one wetland within Project Area 2 that was determined to be isolated and non-jurisdictional. The wetland is 0.15 acres in size and is a depressional wetland surrounded completely by uplands. The wetland is positioned approximately 1-2 feet lower in the landscape than the surrounding uplands. Based on a review of offsite information including aerial photographs and LIDAR, no swales, ditches, or other features appear to be coming out of the wetland. The wetland is also not located in close proximity to a tributary and is therefore not considered to be adjacent to a tributary. Therefore, it appears that the wetland has no apparent shallow subsurface hydrologic connection, and no apparent physical, chemical, or biological connection, to waters of the U.S. In addition, the wetland has no apparent ecological interconnection to waters of the U.S. For these reasons, the wetland was determined to be isolated and non-jurisdictional, and therefore not regulated by Section 404 of the CWA. This wetland was previously determined to be isolated in the original jurisdictional determination issued April 21, 2015. A Corps project manager previously visited the site on February 2, 2015. Based on the review of recent aerial photographs, it does not appear that site conditions have changed.**

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
