in area. This wetland is comprised of a geographically distinct polygonal boundary which is not contiguously abutting other jurisdictional waters, and exhibits no other adjacency factors that would support bordering or neighboring adjacency. Most conspicuously, this wetland has no type of hydrologic connectivity to jurisdictional waters. The regulator who made the field visit walked around the wetland, and verified that local topography precluded drainage to any water of the U.S. On this basis, the 0.22-acre freshwater wetland is isolated and non-jurisdictional.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Physical – Wetland BB contributes to flow maintenance functions, including retaining runoff inflow and storing flood water temporarily. Flow maintenance results in the reduction of downstream peak flows (discharge and volume), helping to maintain seasonal flow volume. According to SCDHEC Bureau of Water, the Allison Creek arm of Lake Wylie (into which this tributary and wetland flow) has two water quality monitoring stations (CW-200 and CW-201). Aquatic life uses are fully supported at CW-201, but not for CW-200 due to phosphorus concentrations and chlorophyll-a excursions as well as 5-day biological oxygen demand. Based on the collective functions described above and their importance to the biological, chemical, and physical integrity of the traditional navigable waters of the Lake Wylie, this office has determined that there is a Significant Nexus between the review area Relevant Reach and its adjacent wetland and the downstream TNW.
