wetland (0.275 acre) receives runoff from developed upland areas. The only output from the isolated wetland appears to be through evapotranspiration. There was a lack of hydrology, hydric soils, and hydric vegetation between the isolated wetland and the concrete lined ditch that sits approximately 200 feet to the north. The identified wetland does meet the 1987 criteria, but do not have either a surface or apparent subsurface hydrological connection to other waters, no apparent ecological, physical, biological, or chemical interconnectivity with other water features including any waters of the U.S., and no apparent connection to interstate or foreign commerce. Therefore, this wetland was determined to be isolated from waters of the U.S. and is not within jurisdiction of Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
