from uplands for the purpose of borrow material. The pond consists of open water and does not meet the three parameters of a wetland. As stated in the Preamble to the November 13, 1986, Regulations found on page 41217 (Federal Register vol. 51 No. 219) "waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United States" are generally not considered waters of the U.S.

There is also one linear ditch feature (Non-JD Feature 2, 454 linear feet) located within the review area. This feature was excavated from uplands, does not carry relatively permanent flow, and does not represent an aquatic resource. On this basis, Non-JD Feature 2 has no potential to be a water of the U.S.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Documentation for the Record only: Significant nexus findings for seasonal RPWs and/or wetlands abutting seasonal RPWs: Seasonal RPW Tributaries 4, 5, 6, 9, and 10, are similar in their physical characteristics, including flow volumes and durations, and are thus appropriately documented collectively in performing functions consistent with the following: **Biological** – these SRPWs include limited riparian area with no adjacent wetlands. However, a variety of biological functions are being performed which include foraging areas for wetland dependent species that move between these streams and stronger flowing tributaries into which they contribute flow. These tributaries contribute organic carbon toward primary productivity of downstream waters, resulting in the nourishment of the downstream food web. **Chemical** – Although restricted to their small drainage areas, these tributaries likely contribute nutrients via runoff from the surrounding uplands, including nitrogen and phosphorus to downstream waters. **Physical** – these tributaries contribute to flow maintenance functions, including contributing runoff inflow from storm events, but do little in the way of storing flood waters. Flow maintenance helps to maintain seasonal flow volume.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

This Form documents the jurisdictional status of wetlands and tributaries on the site that represent waters of the U.S. There are also two non-jurisdictional features present, as described below.

There is one pond (Non-JD Feature 1, 5.38 acres) located within the project review area. The pond was excavated from uplands for the purpose of borrow material. The pond consists of open water and does not meet the three parameters of a wetland. As stated in the Preamble to the November 13, 1986, Regulations found on page 41217 (Federal Register vol. 51 No. 219) "waterfilled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United States" are generally not considered waters of the U.S.

There is also one linear ditch feature (Non-JD Feature 2, 454 linear feet) located within the review area. This feature was excavated from uplands, does not carry relatively permanent flow, and does not represent an aquatic resource. On this basis, Non-JD Feature 2 has no potential to be a water of the U.S.
