purpose of silviculture activities. These ditches exhibited no characteristics of flow and were determined to be non-jurisdictional.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The tributary exhibited a OHWM (impressed line along the banks), and a hard sandy bottom. At time of the site visit, water was backed up within the tributary due to downstream beaver activity.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** A desktop review was performed for this request. However, a site visit was conducted on June 2, 2017, in which the onsite wetland and tributary were verified (Letter issued December 20, 2017). This form assesses a 1,297.22 acre site that consists of 50.03 acres of jurisdictional freshwater wetlands and 16,136 linear feet of tributary. The onsite tributary is a perennial RPW (Cypress Creek) that flows through the onsite wetlands and onsite uplands. The portion of the tributary that flows through the uplands has previously been mechanically straightened and is maintained for drainage purposes. The downstream portion of the tributary that flows through the wetland is more natural with meandering characteristics. In addition, the site consists of a series of 15 man-made ditches excavated for silviculture activities. The ditches were excavated for the purpose of carrying surface water off of the site. According to recent information submitted by the consultant, the site is still being used for silviculture activities. After researching the best available information, it does not appear that anything has changed within the landscape of the site to alter the onsite wetlands or tributary.
