line approximately 600 feet east of the US 76 Bridge across US 15 (North Main Street) in Sumter. Drainage Feature B was created to form a connection from the existing culvert and a tributary that has been identified as Stream A, outside of this AJD project area. Drainage Feature B receives flow from the culvert which appears to be part of the drainage system that may have been established for the US 76 Bridge, western roadway approaches to the US 76 Bridge and the area directly around the US 76 Bridge across the abandoned railroad, including South Pike East Street. Due to this relatively small drainage area (< 3 acres), flow within Drainage Feature B appears to be directly driven by precipitation events collected from US 76 and drainage ditches along a portion of South Pike East Street. In addition, due to the proximity of Stream A (< 100 feet away) and a result of precipitation events causing high flows in Stream A, it appears that water from Stream A may back flow into Drainage Feature B. During the April 22, 2022 field view, the Corps observed no flow in Drainage Feature B even though according to APT, the conditions in this location were expected to be wetter than normal on that date. The Corps determined this feature is not a water of the U.S. or under jurisdiction of Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site includes a ditch (Drainage Feature B) with a 76-foot-long feature with an established bed and bank from the outlet of an existing 36-inch diameter concrete culvert under the US 76 bridge across the abandoned railroad line approximately 600 feet east of the US 76 Bridge across US 15 (North Main Street) in Sumter. Drainage Feature B was created to form a connection from the existing culvert and a tributary that has been identified as Stream A, outside of this AJD project area. Drainage Feature B receives flow from the culvert which appears to be part of the drainage system that may have been established for the US 76 Bridge, western roadway approaches to the US 76 Bridge and the area directly around the US 76 Bridge across the abandoned railroad, including South Pike East Street. Due to this relatively small drainage area (< 3 acres), flow within Drainage Feature B appears to be directly driven by precipitation events collected from US 76 and drainage ditches along a portion of South Pike East Street. In addition, due to the proximity of Stream A (< 100 feet away) and a result of precipitation events causing high flows in Stream A, it appears that water from Stream A may back flow into Drainage Feature B. During the April 22, 2022 field view, the Corps observed no flow in Drainage Feature B even though according to APT, the conditions in this location were expected to be wetter than normal on that date.

The features documented on this form include waters that are not jurisdictional. Corps review of the submitted information along with the observations made during the field view confirm that even though Drainage Feature B is confined within defined bed and banks, it is not a tributary since it only contains water and has flow as result of precipitation events. Therefore, the Corps has determined that Drainage Feature B is not a tributary and is not considered to be a jurisdictional water.
