- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The site contains one upland excavated stormwater drainage ditch. This feature is not depicted on USGS topo maps, NWIs, or NHD. It was determined to have been excavated out of uplands and to drain only uplands and is therefore determined to be non-jurisdictional. This ditch was first documented in AJD SAC-2003-35035. Historically, this feature provided a hydrologic connection for multiple upstream wetlands however, the development of several single-family residential developments have altered the landscape and this feature now functions primarily as**

stormwater conveyance for roadside drainage in surrounding uplands. In addition, this feature was observed in the field and did not contain indicators of perennial flow. The channel had a mucky bottom covered with leaf litter and also contained established vegetation.

Several shallow drainage swales are located on site. These features were determined to have been constructed in uplands. They do not contain any indicators of flow and were overgrown with grasses and vegetation. These features were determined not to be aquatic resources.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 22.96 acre tract that was determined not to contain any areas subject to the Corps' jurisdiction. The site contains one upland excavated stormwater drainage ditch. This feature is not depicted on USGS topo maps, NWIs, or NHD. It was determined to have been excavated out of uplands and to drain only uplands and is therefore determined to be non-jurisdictional. This ditch was first documented in AJD SAC-2003-35035. Historically, this feature provided a hydrologic connection for multiple upstream wetlands however, the development of several single-family residential developments have altered the landscape and this feature now functions primarily as stormwater conveyance for roadside drainage in surrounding uplands. In addition, this feature was observed in the field and did not contain indicators of perennial flow. The channel had a mucky bottom covered with leaf litter and also contained established vegetation.

Several shallow drainage swales are also located on site. These features were determined to have been constructed in uplands. They do not contain any indicators of flow and were overgrown with grasses and vegetation. These features were determined not to be aquatic resources. .
