meet the 3 parameters of a wetland. For these reasons, the ponds were determined to be non-jurisdictional and not regulated by Section 404 of the CWA or Section 10 of the RHA.

Summarize rationale supporting conclusion that wetland is “adjacent”: **Wetland B is a freshwater wetland that is contiguous with and abutting the Unnamed Tidal Creek of the Kiawah River (Tidal Marsh TM). Wetland A is a freshwater wetland that is in close proximity to the Unnamed Tidal Creek of the Kiawah River. For these reasons, Wetlands A and B are jurisdictional and subject to regulation under Section 404 of the Clean Water Act.**

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project review area is approximately 5.18 acres in size and includes Tidal Marsh TB, which are part of the Tidal Impoundment of the Kiawah River, and Tidal Marsh TA and TM, which are part of the Unnamed Tidal Creek of the Kiawah River, are considered TNW and thus jurisdictional and regulated by Section 10 of the RHA and Section 404 of the CWA. The project review area also includes two freshwater Wetlands A and B, which are jurisdictional and regulated by Section 404 of the CWA. The project review area also includes two non-jurisdictional ponds that are not subject to regulation under Section 10 of the RHA and Section 404 of the CWA.
