Explain: A potentially jurisdictional pond and a linear feature are located within the review area. This entire 18.44 acre site is mapped Kenansville fine sand and Yauhannah fine sandy loam on the soil survey, which are non-hydric soils. The pond is mapped PUBHx, which is an excavated freshwater pond, on the NWIs. The topographic map and NHD do not depict the pond nor the linear feature on site and no potential aquatic resources are depicted on site. Both the pond and the linear feature were determined to have been excavated out of uplands; therefore, they were determined to be non-jurisdictional features.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** A potentially jurisdictional pond and a linear feature are located within the review area. This entire 18.44 acre site is mapped Kenansville fine sand and Yauhannah fine sandy loam on the soil survey, which are non-hydric soils. The pond is mapped PUBHx, which is an excavated freshwater pond, on the NWIs. The topographic map and NHD do not depict the pond nor the linear feature on site and no potential aquatic resources are depicted on site. Both the pond and the linear feature were determined to have been excavated out of uplands; therefore, they were determined to be non-jurisdictional features.
