Explain: **The 1.7-acre site has two wetlands (W8=0.09 acre and W2=0.07 acre) located towards the middle of the site. W8 is located west of W2. There are culverts from a possible old roadbed and berm between W8 and W2. There is also a berm between W2 and a non-jurisdictional drainage located on the site. There are no culverts or signs of connection**

between the wetland and the non-jurisdictional drainage. The drainage loses bed and bank and spreads out as it gets further away from the wetlands and does not provide a continuous connection. This drainage eventually leads to a culvert that does under the road but does not provide a continuous connection to downstream waters.

There are no signs of jurisdictional drainage features or shallow subsurface flow from the non-jurisdictional wetlands to any other waters on-site or off-site. The non-jurisdictional wetlands show no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the non-jurisdictional wetlands and waters of the U.S. This office has determined that the wetlands are isolated from waters of the U.S. and are not within jurisdiction of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
