Explain: **The 5.3-acre site has one wetland (W9=0.27) located in the southern portion of the site. W9 is an old upland dug pond that has naturalized into a wetland. This is an old treatment pond that has a berm around it and was not originally constructed on a water of the US. There is a pipe located high up on the berm, but it is above the elevation of**

the water and there are no signs of flow near the pipe. This pipe does not provide a connection to downstream waters of the US. The treatment pond was not maintained and has naturalized to a wetland over the years. There were no signs of any connection to the downstream waters.

There are no signs of jurisdictional drainage features or shallow subsurface flow from the non-jurisdictional wetland to any other waters on-site or off-site. The non-jurisdictional wetland shows no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the non-jurisdictional wetland and waters of the U.S. This office has determined that the wetland is isolated from waters of the U.S. and are not within jurisdiction of the Clean Water Act.

Additionally this site has two upland dug ponds (P2=0.06 acre and P3=0.36 acre) that were also previously used for treatment purposes. These ponds were not constructed on waters of the US and are surrounded by uplands.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: **The 5.3-acre site has one wetland (W9=0.27) located in the southern portion of the site. W9 is an old upland dug pond that has naturalized into a wetland. This is an old treatment pond that has a berm around it and was not originally constructed on a water of the US. There is a pipe located high up on the berm, but it is above the elevation of the water and there are no signs of flow near the pipe. This pipe does not provide a connection to downstream waters of the US. The treatment pond was not maintained and has naturalized to a wetland over the years. There were no signs of any connection to the downstream waters.**

Additionally this site has two upland dug ponds (P2=0.06 acre and P3=0.36 acre) that were also previously used for treatment purposes. These ponds were not constructed on waters of the US and are surrounded by uplands.
