C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Wetland boundaries and limits of jurisdiction were established using the 1987 field manual. The soil series, Leon is hydric throughout its entire map unit as listed in the Horry County Hydric Soils List. Wetlands within the project area, make up a portion of a large wetland system which continues offsite, and is intersected by the OHWM of Beaverdam Swamp that flows into Stanely Creek which discharges into the Waccamaw River. A review of the Horry County NWI data shows that the large wetland complex continues offsite and is intersected by the OHWM of Beaverdam Swamp tributary. A review of aerial photos, topographic maps, Horry County Soil Survey, and Horry County Drainage Canal Study revealed that the tributary was determined to be an RPW with perennial flow at least 90% of the year. Aerial photos depict a signature of a defined channel discharging directly into another PRPW, Topographic maps depicts a solid blue line which is the symbol that represents a tributary with perennial flow, Horry County Drainage Canal Study depicts a main drainage canal (L-2) which represents a tributary with perennial flow, and Horry County Soil Survey depicts a symbol that represents a tributary with intermittent flow.

Two previous wetland determinations were made by this office, on larger parcels that encompassed this project area and that established jurisdiction of the wetlands onsite. These determinations were dated October 24, 2005 and November 16, 2010. The most recent letter is set to expire on November 16, 2015. The wetlands within the project area have not been disturbed or altered since the initial letter.
