C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 108.26 acre project area currently consist of an established Golf Course that was constructed under a previous Corps determination stating that there were no wetlands within the project area. The golf course is located within a densely developed area. There are eight upland excavated non-jurisdictional golf course ponds located within the boundaries of the project area. These ponds are determined to have been excavated out of uplands and are not considered an impoundment of a water of the United States. The USGS topographic survey information within Myrtle Beach Quad depicts the project area as developed uplands that contain a water feature. This water feature is depicted as surrounded on all sides by uplands and is not connected to a blue line feature. The topographic survey information also depicts wetlands in the northwest corner of the project area, however, a review of aerial photographs reveals that this area is completely developed and wetlands are not present. A data sheet submitted by S&ME revealed a lack of hydrology indicators, hydrophytic vegetation, and hydric soils on site. Based on the above information the project area is determined to consist entirely of uplands.
