- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:  
**Potential wetlands on site did not meet all three parameters as outlined in the 1987 Delineation manual. Specifically, Hydric soils were not present on-site.**

There are two non-jurisdictional ditches located within the project boundary. Ditch 1 runs along the entire western project boundary and ditch 2 runs along a portion of the eastern project boundary, as depicted in the sketch prepared by the Corps, titled “SAC-2015-00213-4S; Supplemental Sketch / TMS# 131-00-01-137 / Darlington County, SC” and dated March 12, 2015. Ditch 1 is a 6’ deep 4.5’ wide man made upland excavated ditch that originates and terminates off-site. This ditch is adjacent to a spoil berm and lined with leaf litter and woody vegetation. This ditch was also determined to be non-jurisdictional in JD SAC-2009-01328-4E on an adjacent site issued on September 16, 2010. Ditch 2 terminates within the boundary of the project area. This ditch is 1’ wide and approx 6” deep. It is filled with leaf litter and debris and no water was observed in this ditch while on site. Both ditches are determined to have been excavated out of uplands and to drain only uplands and therefore are not jurisdictional.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
