does not exhibit the features of an impoundment. It is overgrown and no longer has an OHWM. This pond is not a Water of the U.S.

The site has one depressional isolated emergent wetland that is 0.41 acres and located within the footprint of an old pond. This wetland is located in the lowest part of the old pond, near the old spillway. There is a blue line stream shown on the topo that runs from the old pond downstrea, but this blue line stream is not there. Downstream from the isolated wetland is the old dam for the pond and then a dry detention pond for a large commercial development. There is nothing located below the spillway for the dry detention pond that would connect the isolated wetland downstream. There is no connection from the isolated wetland to the off-site dry detention pond. Any possible drainage or feature is over 1,000 feet away from the isolated wetland. There are no signs of drainage features, shallow subsurface flow or overland flow off-site or to other waters on-site. This isolated wetland shows no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetland and waters of the U.S. This office has determined that this wetland is isolated from waters of the U.S. and not within the jurisdiction of the Clean Water Act.

# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B.** ADDITIONAL COMMENTS TO SUPPORT JD: The 4.14 acre site contains the footprint of an old pond. This pond was breached over 20 years ago. This pond does not exhibit the features of an impoundment. It is overgrown and no longer has an OHWM. This pond is not a Water of the U.S.

The site has one depressional isolated emergent wetland that is 0.41 acres and located within the footprint of an old pond. This wetland is located in the lowest part of the old pond, near the old spillway. There is a blue line stream shown on the topo that runs from the old pond downstrea, but this blue line stream is not there. Downstream from the isolated wetland is the old dam for the pond and then a dry detention pond for a large commercial development. There is nothing located below the spillway for the dry detention pond that would connect the isolated wetland downstream. There is no connection from the isolated wetland to the offsite dry detention pond. Any possible drainage or feature is over 1,000 feet away from the isolated wetland. There are no signs of drainage features, shallow subsurface flow or overland flow off-site or to other waters on-site. This isolated wetland shows no evidence of biological, chemical, or physical connectivity to waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetland and waters of the U.S. This office has determined that this wetland is isolated from waters of the U.S. and not within the jurisdiction of the Clean Water Act.

The site also has an upland dug excavated stormwater pond. This pond is located uphill from the isolated wetland, but still within the footprint of the old pond. This pond drains only uplands. This office has determined this pond is upland dug and is not a Water of the U.S.
