is located in the southwestern portion of the site and has various storm drain inlets. It is open water and has no vegetation in it, therefore does not meet the 3 parameters of a wetland. There is also a non-jurisdictional ditch located in the central portion of the site, just north of the stormwater pond. It is approximately 136 feet in length, 5 feet wide, and 4-5 feet deep, and was excavated from uplands. It collects stormwater from the nearby parking facilities and discharges to the stormwater pond. It is not connected to other features. There are also 5 swales that topographically lower lying areas, but which do not carry any water or connect to any wetlands. By definition, these swales are non-jurisdictional. These features are located on a supplemental drawing in the administrative record. For these reasons, the pond the ditch and the swales were determined to be non-jurisdictional and not regulated by section 404 of the Clean Water Act.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
