usually indicates the presence of a tributary. These linear features were determined to be man-made and excavated out of uplands on site. Therefore, all of the linear features on site were determined to be non-jurisdictional ditches. Five areas depicted on the soil survey as Coxville and Rains, which are hydric soils, were also evaluated. These areas are mapped uplands (U21) on the NWIs, and are depicted as agricultural fields on the aerials and cleared uplands on the topographic map. Soil samples taken by the agent in these areas determined that the site does not contain wetlands due to the absence of hydrology indicators and the presence of drainage ditches within these areas. Therefore, the entire site was determined to be void of any Waters of the US.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
