**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

This feature is located outside of the boundaries of the project area based on State Plane coordinates demarcating the project boundary submitted by the agent. Two linear features bisect the project area on either side of Poston Street. These features were determined to be road side drainage ditches excavated out of uplands for the purpose of draining upland storm water run-off. These features were determined to be non-jurisdictional.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This form addresses a 1 acre corridor, located in the Town of Hemingway that was determined to consist entirely of uplands. NWIs depict the project area as a combination of residential uplands and upland cropland/pasture. The USGS topographic information within Henry Quad depicts the project area as forested uplands bisected by existing roadways and surrounded by residential development. There are no blue line features or other symbols that would typically represent a WOUS depicted within or in the vicinity of the project area. Williamsburg County Soil Survey information depicts the project area as being comprised of the following soil types: Yemassee; a somewhat poorly drained partially hydric sandy loam and Ogeechee; a poorly drained all hydric fine sandy loam. The majority of the project area is depicted as Yemassee. Two small areas are mapped Ogeechee. The first is located near the center of the project area and the other near the south west project boundary. Data sheets and site photos submitted by the consultant reveal that soils near the center of the project area did not meet any Hydric Soil Indicators. LiDAR data, site photos, and aerial photographs reveal that the area near the south west project boundary is an existing pump station located in uplands. Site photos and data forms submitted by the agent reveal that the project area lacks any indicators of hydrology. Williamsburg County LiDAR depicts a linear feature just outside of the south west project boundary. This feature is located outside of the boundaries of the project area based on State Plane coordinates demarcating the project boundary submitted by the agent. Two linear features bisect the project area on either side of Poston Street. These features were determined to be road side drainage ditches excavated out of uplands for the purpose of draining upland storm water run-off. These features were determined to be non-jurisdictional. Based to the consistent upland depiction within the desktop resources available to this office, in combination with the wetlands determination data forms and site photos submitted by the agent, this site was determined to consist entirely of uplands.
