This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Area in review (project area 0.89 acres / Lot 7) contained no wetlands or other Waters of the U.S. (WOUS). This site is comprised primarily of Lakeland soils (non-hydric), Horry County NWI data depict the site primarily as U11 (uplands) with a small portion depicted as PUBHx (open water). USGS Topographic Maps depict the site as forested uplands with no wetlands. The site is approximately 3700 linear feet from the nearest WOUS (Atlantic Ocean).

Located onsite is an upland excavated non-jurisdictional ornamental pond that does not connect to any other WOUS.
