C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is comprised of 18.58 acres of which 2.40 acres have been determined to be adjacent to an offsite tributary. The wetlands onsite have been determined to be non-abutting the offsite tributary. A previous determination, SAC#2011-00591-3H, determined that the onsite wetlands within the project area and all other similarly situated wetlands located within the drainage area of the offsite tributary along with the tributary to have a significant nexus (SND) to the downstream TNW (AIWW). Therefore, a significant nexus was not performed based on the above previous referenced SND and the fact that this determination is still valid. In addition, on a previous determination, SAC#2013-01298-3B, the onsite stormwater ditch has been determined to have been excavated from within uplands. This ditch conveys only stormwater in response to rainfall. A site visit was not performed.
