### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The project area is a 36,305 sq.ft undeveloped residential lot. The project area contains approximately 0.3 acres of freshwater wetlands that directly abut an impounded water of the U.S (Dogwood Lake) that was dug out of wetlands. An offsite tributary of Dogwood Lake was impounded as seen on a site visit conducted on August 16, 2015 under SAC- 2015-01223-3NY. USGS topographic survey information shows the project area as a forested area directly abutting an impoundment of waters of the U.S. NWI maps depict the area as residential (U11) and Dogwood Lake as open water (LIUBHx). Soil survey information maps the project area as Lakeland soil. .
