

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses approximately 1.28 acres located off of Seaford road in Longs SC. USGS topographic survey information depicts the project area as forested uplands and is void of any blue lines or wetland symbols. Soil survey information show the project area is comprised of the hydric soils Bladen and Hobcaw. NWI maps depict the area as upland residential. The project area is boarded by a golf course fairway and a developed residential community on 3 of its 4 sides. The project area is approximately 350 linear feet from the nearest jurisdictional feature (Sac-2010-00581-3JY) and is separated by a paved and maintained county road. Based on previous determinations and the above listed resources the project area was determined to be void of aquatic resources.
