- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The site contains a single isolated non-jurisdictional freshwater wetland, three upland excavated non-jurisdictional ditch, and a single upland excavated non-jurisdictional pond. The isolated wetland is situated adjacent to and north of US Highway 701. The area adjacent to the isolated wetland covered by this review does not contain a roadside ditch. The remaining three sides of the isolated wetland are surrounded by areas that lack the appropriate hydrology found in the wetland. The isolated wetland onsite was observed to have a bowl shaped depressional geomorphic position and all water contained within the wetland is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps depict upland that were not observed in the field. No linear features (i.e. blue lines), in the vicinity of the isolated wetlands, are depicted on the topographic maps.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site contains a single isolated non-jurisdictional freshwater wetland (5.02 acres), three upland excavated non-jurisdictional ditch, and a single upland excavated non-jurisdictional pond. The isolated wetland is situated adjacent to and north of US Highway 701 and does not contain a roadside ditch. The remaining three sides of the isolated wetland are surrounded by areas that lack the appropriate hydrology found in the wetland. The isolated wetland onsite was

observed to have a bowl shaped depressional geomorphic position and all water contained within the wetland is retained within the wetland boundaries and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetlands were determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps depict upland that were not observed in the field. No linear features (i.e. blue lines), in the vicinity of the isolated wetlands, are depicted on the topographic maps.

Although the non-jurisdictional ditch (Ditch #2) located on the north section of the property discharges into an offsite ditch, the remaining two ditches are part of a closed system and do not convey water offsite. Ditch 3 bisects a portion of the isolated wetland and connects near the western boarder of the property with ditch #1. A close inspection of these two features revealed that all the water contained within them was stagnant, exhibited no indications of flow, and lack any discernable outlet; only connecting with the non-jurisdictional upland excavated pond located in the northwest corner of the property. The transfer of surface water, any is completely contained between the isolated wetland, the upland excavated pond, and ditches 1 & 3 and in no way are connected with other WOUS.

This site was assessed on a single basis form.
