the south. There is a non-jurisdictional upland excavated pond onsite that is approximately 0.05 acre. As stated in the Preamble to the November 13, 1986, Regulation found on page 41217 (Federal Register vol. 51 No. 219) "waterfilled depressions created in dry land indicidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and resulting body of water meets the definition of waters of the United Sates" are generally not considered waters of the U.S.

The feature exhibits no apparent connection/conveyance to waters of the United States; to include no physical, chemical, or biological connections. In addition, this feature does not exhibit any apparent ecological interconnectivity with other water features, including any waters of the United States, and there is no apparent connection to interstate or foreign commerce.

For these reasons, the pond was determined to be non-jurisdictional and not regulated by section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

There are no *"navigable waters of the U.S."* within the specified review area nor are there *"waters of the U.S."*. The site contains undeveloped land zoned for commercial use and an aquatic feature determined not to be subject to the jurisdiction under the CWA.
