Explain: **The 24.67 acre site contains an upland dug pond which has been in place for at least 46 years according to aerial photography from 1970. This pond does not contain any drainage structures and is gradual in slope with no**

defined berm on the backside. It appears that the pond is subject to seasonal precipitation patterns. These seasonal precipitation patterns have likely caused water to back up behind the pond to create a 0.31 acre forested isolated wetland. There is no blue line topo feature, only the pond identified. The soil SSURGO data identifies Wynott-Winnsboro complex and the 1963 York County Soil Survey identifies the soil as Enon sandy loam. The USFWS NWI data shows a pond, stream, and wetland all connected but the stream was not observed in the field.

Vegetation, soil, and hydrology were examined below the pond and nothing indicated that water flows or connects to the nearby upland pond or the isolated wetland. Additional soil core samples were collected in areas most likely of possible flow. Soils were found to have high chroma values and no models indicative of drainage. These features showed no signs of relatively permanent flow or an OHWM. There are no signs of drainage features, shallow subsurface flow, or overland flow to any waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetland and waters of the U.S. This office has determined that the pond is upland dug and this wetland is isolated from waters of the U.S. and not within the jurisdiction of the Clean Water Act.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: **The 24.67 acre site contains an upland dug pond which has been in place for at least 46 years according to aerial photography from 1970. This pond does not contain any drainage structures and is gradual in slope with no defined berm on the backside. It appears that the pond is subject to seasonal precipitation patterns. These seasonal precipitation patterns have likely caused water to back up behind the pond to create a 0.31 acre forested isolated wetland. There is no blue line topo feature, only the pond identified. The soil SSURGO data identifies Wynott-Winnsboro complex and the 1963 York County Soil Survey identifies the soil as Enon sandy loam. The USFWS NWI data shows a pond, stream, and wetland all connected but the stream was not observed in the field.**

**Vegetation, soil, and hydrology were examined below the pond and nothing indicated that water flows or connects to the nearby upland pond or the isolated wetland. Additional soil core samples were collected in areas most likely of possible flow. Soils were found to have high chroma values and no models indicative of drainage. These features showed no signs of relatively permanent flow or an OHWM. There are no signs of drainage features, shallow subsurface flow, or overland flow to any waters of the U.S. There is also no apparent connection to interstate or foreign commerce. In addition, there is no apparent evidence of ecological interconnectivity between the isolated wetland and waters of the U.S. This office has determined that the pond is upland dug and this wetland is isolated from waters of the U.S. and not within the jurisdiction of the Clean Water Act.**
