### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The**

wetlands located onsite directly about this onsite, unnamed blue line stream of Canterhill Swamp. The tributary feature had bed and bank, ordinary high water mark (OHWM), and was carrying relatively permanent surface water flow during the date of the site visit on January 4, 2017. Due to the capacity of flow observed, as well as tributary dimensions, the flow regime of the tributary would be classified as perennial. The tributary flows onsite for approximately 1170 linear feet.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The reference property is surveyed to be 62.06 acres. Of that acreage, 41.25 acres of the property meet the 3 parameters of a wetland. These wetland are determined to be waters of the U.S. and therefore subject to CWA 404 jurisdiction, as they are directly abutting an onsite, unnamed blue line stream/perennial tributary of canterhill Swamp that directly flows into a TNW (Back River). This tributary flows onsite for approximately 1170 linear feet. The reference property also contains 1.84 acres of waters that are not subject to jurisdiction under Section 404 of the CWA, nor Section 10 of the RHA. These features are determined to be non-jurisdictional, upland excavated ponds, as they were wholly excavated in upland, and currently serve the purpose of accepting stormwater discharge from the reference property and surrounding uplands.
