- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There is one linear feature onsite. It is approximately 3 feet wide, approximately 1 foot deep and 137 feet long. The feature is filled with leaf litter and mature trees and does not appear to have an OHWM. This feature originates on the site and runs offsite where it ties in with the roadside ditch along Highway 176. The onsite feature appears to have been constructed to drain the onsite uplands. The feature was excavated from uplands. For these reasons, this feature was determined to be non-jurisdictional.

There are also two very small borrow pits onsite (Feature B 0.04 acre and Feature C 0.01 acre) on the upland portion of the tract. As stated in the Preamble to the November 13, 1986, Regulation found on page 41217 (Federal Register vol. 51 No. 219) “water filled depressions created in dry land incidental to construction activity and pits excavated in dry land for the purpose of obtaining fill, sand, or gravel unless and until the construction or excavation operation is abandoned and the resulting body of water meets the definition of waters of the United States” are generally not considered waters of the U. S. These two areas were excavated from high ground and contain some water with no vegetation. For these reasons, these areas were determined to be non-jurisdictional under Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
