Explain: **One isolated non-jurisdictional wetland is located on site. The entire perimeter of this wetland was examined in the field during a site visit conducted on 1/31/18. The wetland is bordered on all sides by non-hydric soils that do not**

show any indicators of hydrology and therefore disrupt any possible hydrologic connection to a downstream TNW. The southern portion of the wetland is bounded by uplands adjacent to a large manmade berm which disrupts any flow offsite to the south. The western side of the wetland is bounded by an asphalt parking lot. The eastern wetland boundary is adjacent to an upland grassy area that was developed in 2000 under AJD 81-98-3498 issued in August 1998. A small shallow drainage swale extends from the northern wetland boundary towards the upland excavated stormwater pond, however this feature is bisected in two places by upland crossings that do not contain culverts and therefore disrupt any hydrologic connection between the wetland and the pond. Additionally, this wetland was originally part of a larger wetland that was determined to be isolated in AJD 81-98-3498 issued in August 1998 and that was partially filled under the original JD.

Additionally, one non-jurisdictional upland excavated pond is located on site. Based on historic aerial photographs, this pond was determined to have been excavated out of uplands first identified in AJD 81-98-3498 issued in August 1998.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The western side of the wetland is bounded by an asphalt parking lot. The eastern wetland boundary is adjacent to an upland grassy area that was filled under AJD 81-98-3498 issued in August 1998. A small shallow drainage swale extends from the northern wetland boundary towards the upland excavated stormwater pond, however this feature is bisected in two places by upland crossings that do not contain culverts and therefore disrupt any hydrologic connection between the wetland and the pond. Additionally, this wetland was originally part of a larger wetland that was determined to be isolated in AJD 81-98-3498 issued in August 1998 and that was partially filled under the original JD.

Additionally, one non-jurisdictional upland excavated pond is located on site. Based on historic aerial photographs, this pond was determined to have been excavated out of uplands first identified in AJD 81-98-3498 issued in August 1998.

One site visit was performed.
