non-jurisdictional. The feature is a depressional wetland pocket surrounded by uplands and positioned lower in the landscape than the surrounding uplands. There were no ditches, swales, or other linear features which would allow the conveyance of flow from the wetland to the downstream TNW. No visible surface hydrologic connections between this wetland and waters of the US appear to be present. In addition, there are no apparent shallow subsurface hydrologic connections, and no apparent physical, chemical, or biological connections to waters of the US. The wetland also has no apparent ecological interconnection to waters of the US. For these reasons, the above referenced wetland was determined to be isolated and non-jurisdictional and therefore not regulated by Section 404 of the CWA.



# C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands.
