- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **A potentially jurisdictional wetland located within the project area was determined to be non-jurisdictional due to the lack of discernable or traceable outfall connections to other Waters of the US. Although in itself the wetland meets the criteria set forth in the 1987 Wetland Delieation Manual and the 2010 Coastal Plain Supplement, a site visit revealed that the wetland onsite is completely encompassed by soils that do not meet the hydrology criteria, and therefor disrupt any possible hydrologic connection to other wetlands or Waters of the US. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Because of topographic elevation differences in the surrounding uplands any surface of subsurface hydrologic connection is inhibited. Topographic maps do not depict any linear features (i.e. blue lines) on the property.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This form addresses 0.67 acres in Conway, SC. 0.18 acres was determined to be isolated non-jurisdictional. The wetland exhibited hydric soils, hydrophytic vegetation, and sufficient indicators of hydrology to satisfy the criteria set forth in the 1987 Wetland Delineation Manual. However, all water located within this wetland has no discernible or traceable outfall or connection to any WOUS. Because of the lack of discernible outfall, topography grades, and lack of evidence of chemical, physical or biological connection, this wetland system has been determined to be isolated, non-jurisdictional.
