- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: A potentially jurisdictional wetland located within the project area was determined to be non-jurisdictional due to the lack of discernable or traceable outfall connections to other Waters of the US. Although in itself the wetland meets the criteria set forth in the 1987 Wetland Delineation Manual and the 2010 Coastal Plain Supplement, a site visit conducted on February 15, 2019, revealed that the wetland onsite is completely surrounded by soils that do not meet the hydrology criteria, and therefore disrupt any possible hydrologic connection to other wetlands or Waters of the US. All water contained within these wetlands is retained within the wetland boundary and percolates to an unknown depth. Because of topographic elevation differences in the surrounding uplands any surface of subsurface hydrologic connection is inhibited.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site was determined to contain one 0.14 acre isolated non-jurisdictional wetland. The entire perimeter of the wetland was observed in the field. The wetland is completely surrounded by non-hydric soils and no surface or shallow subsurface connection to another water of the U.S. was evident during the site visit or could be found after a review of aerial photography, and topographic maps. All water contained within the wetland is retained within the wetland boundary and percolates to an unknown depth. Because of the lack of discernable outfall, topography grades, and lack of evidence of chemical or biological connection, the wetland was determined to be isolated non-jurisdictional and not connected to any other water of the U.S. Topographic maps do not depict any linear features (i.e. blue lines) on the property.

One 0.17 acre jurisdictional wetland is also located onsite. This wetland is addressed on Basis Form 2 of 2 of this determination..
