**REVIEW AREA ONLY INCLUDES DRY LAND:** The property consists of approximately 2 acres of uplands. A desktop review was performed for the site. According to soil survey information, the site is comprised of all non-hydric soil and is listed as uplands on the National Wetlands Inventory map. The tributary (i.e. Hills Creek) is located just off the southern property boundary. The unnamed blue line depicted on the topo map along the western property boundary is also off of the property.
