C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is comprised of 95 acres of which approximately 27 acres have been identified as freshwater wetlands. Of the 27 acres of wetlands, less than 1 acre (0.88 acres) (one wetland located centrally within the project area) has been determined to be isolated, non-jurisdictional. The remaining 25.89 acres (Wetlands located on the eastern property line) are jurisdictional and documented as such on basis form 2 of 2 of this determination. In addition, the project area contains an RPW that is located approximately 1,200 feet southwest from the delineated boundary of the onsite isolated wetland. The following is documented under the previous Jurisdictional Determination (SAC-2015-00054-3H) letter dated February 6, 2015: "The forested, isolated, freshwater wetland located within the project area has been determined to be completely surrounded by non-hydric soils and no surface or shallow subsurface connection to any waters of the U.S. (WOUS) was evident during the site visit which consisted of walking the entire delineated wetland boundary. This wetland exhibited hydric soils, hydrophytic vegetation, and sufficient indicators of hydrology to satisfy the criteria set forth in the 1987 Wetland Delineation Manual. However, all water located within this wetland has no discernible or traceable outfall or connection to any WOUS. Chemically, the wetland does not affect any WOUS in the absorption / treatment of nutrients, runoff, and pollutants. Physically, the topographic location of the wetland and its relation to other WOUS is such that water in this wetland is retained and eventually percolates through the soil to groundwater only, to an unknown depth, providing little if any stormwater attenuation. Biologically, this wetland is not essential in providing organic carbons in the form of their collective primary productivity to downstream waters, resulting in the nourishment of the downstream food web. Because of the lack of discernible outfall, topography grades, and lack of evidence of chemical, physical or biological connection, this wetland system has been determined to be isolated, non-jurisdictional." Based on a review of the applicant's submittal and a desktop review of aerial photos which revealed no landscape changes from the previous Jurisdictional Determination within the project area and surrounding properties, a site visit was not warranted for this determination.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The project area is comprised of 95 acres of which 26.77 acres have been identified as freshwater wetlands. Of the 26.77 acres of wetlands, less than 1 acre (0.88 acres) (one wetland located centrally within the project area) has been determined to be isolated, non-jurisdictional. The remaining 25.89 acres (Wetlands located on the eastern property line) are jurisdictional and documented as such on this basis form along with a perennial RPW located onsite. The onsite tributary has been previously documented as a tributary with a flow regime of perennial under the following Jurisdictional Determinations: SAC-2012-00241-3- letter dated 5/2/12; SAC 2014-00857-3 – Letter dated 11/10/14; and SAC 2012-00661-3 – Letter dated 7/30/12, SAC-2015-00054-3H, letter dated February 6, 2015. Onsite jurisdictional wetlands are directly abutting the onsite tributary which flows directly into the AIWW which is a TNW.

Non-jurisdictional features are documented on basis form 1 of 2 of this determination.
