The area did not satisfy all three wetland factors (hydrology, hydric soils, hydrophytic vegetation) in normal circumstances. Additionally, the location of the pond does not lie below the ordinary high water mark or the high tide line of a jurisdictional water. Therefore, this office has determined this pond to be situated in uplands and therefore an excluded non-jurisdictional water.
Excluded Ditch	300 feet	(b)(5) Ditch that is not an (a)(1) or (a)(2) water, and those portions of a ditch constructed in an (a)(4) water that do not satisfy the conditions of (c)(1)	The ditch segment on this parcel represents 300 feet of ditch excavated within uplands and that does not meet criteria as any category of water. The ditch does carry flow, but does so only in response to precipitation.
