C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The forms addresses 5.51 acres of uplands in the Conway, SC. The project site is mostly forested with a driveway, warehouse, a maintained lawn and cell tower. Data points taken by the agent in area previous delineated as wetlands (2006) showed the area lacked hydric soils and hydrology. No primary indicators of wetland hydrology were present. There was no saturation present within the top 16 inches of the soil. The soil had greater than 30% uncoated sand grains within the top 12 inches. The project site is located in an area that received excessive rainfall over a 24-month period with no ponding evidence present. The project site has several upland excavated ditches on site, as well along the perimeter of the project boundary. This determination was made using the best available desktop resources and information submitted by the agent.
