#### MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), <sup>1</sup> SAC-2024-00641, MFR 1 of 1<sup>2</sup>

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.<sup>3</sup> AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.<sup>4</sup> For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),<sup>5</sup> the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

The review area is located within a portion of Cypress Bay. The entire 90.59 acres review area consists of wetlands. The review area is bordered by a recreational park (Patriot Park) to the west and Loring Mill Road to the east. North and south of the review area are a continuation of Cypress Bay. The site has been historically used for silviculture. A previous AJD was provided for the site, dated March 9, 2007.

- 4. NEAREST TRADITIONAL NAVIGABLE WATER (TNW), INTERSTATE WATER, OR THE TERRITORIAL SEAS TO WHICH THE AQUATIC RESOURCE IS CONNECTED. N/A. The aquatic resources contain no connection to a TNW, interstate water, or territorial seas. 6
- 5. FLOWPATH FROM THE SUBJECT AQUATIC RESOURCES TO A TNW, INTERSTATE WATER, OR THE TERRITORIAL SEAS. N/A. There is no discernable flow path to a TNW, interstate water, or the territorial seas. A linear conveyance exists Cypress Bay to the north, flows via culvert under Patriot Parkway until Brushwood Drive. At Brushwood Drive, the linear conveyance flows into a storm sewer system, severing any discernable flow path connection. Furthermore, a linear conveyance exits the review area to the east, however, there is no discernable connection from the conveyance to a requisite water.

Non-Jurisdictional Wetland 1 is a freshwater, non-tidal wetland, that exhibited hydric soils, hydrophytic vegetation, and indicators of hydrology, which satisfied the criteria set forth in the 1987 Corps' Wetland delineation Manual and the Atlantic and Gulf Coastal Plain Regional Supplement. A site visit conducted on March 18, 2025, confirmed the wetland boundaries, and that the wetlands do not directly abut a requisite water. The wetland is mapped as a portion of Cypress Bay on USGS topographic maps, and there is no blue line symbology directly abutting the wetland. The wetland is mapped as a freshwater forested/shrub wetland (PFO4Bd) on NWI maps. The wetland is mapped as Rains (100% hydric rating) on NRCS soils surveys.
