MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime
Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322
(2023),¹ SAC-2025-00501 (MFR 1 of 1)²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 *Rapanos-Carabell* guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the *Sackett* decision (reference 2.d.) in evaluating jurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of “waters of the United States” found in the pre-2015 regulatory regime and consistent with the Supreme Court’s decision in *Sackett*. This AJD did not rely on the 2023 “Revised Definition of ‘Waters of the United States,’” as

The 10.5-acre area of review is a subsection of a larger project evaluated under SAC-2006-03606, Alcolu Industrial and Technology Park. This previous AJD evaluated a much larger tract and identified the wetland currently included under this SAC number as a jurisdictional wetland connected to an unnamed tributary of the Pocataligo River via a continuous surface connection through and upland excavated agricultural ditch. In light of the EPA Memorandum dated March 12, 2025, titled “MEMORANDUM TO THE FIELD BETWEEN THE U.S. DEPARTMENT OF THE ARMY, U.S. ARMY CORPS OF ENGINEERS AND THE U.S. ENVIRONMENTAL PROTECTION AGENCY CONCERNING THE PROPER IMPLEMENTATION OF “CONTINUOUS SURFACE CONNECTION” UNDER THE DEFINITION OF “WATERS OF THE UNITED STATES” UNDER THE CLEAN WATER ACT” this wetland does not maintain a jurisdictional connection using the guidance outlined in the memorandum referenced above. In this current review the wetland, ‘Wetland 1’ as labeled on the referenced map, is an isolated feature not subject to the jurisdiction of Section 404 of the CWA.

Wetland 1: Of approximately 1.185 acres originally identified in SAC-2006-03606, is a concave depression with emergent vascular aquatic vegetation, standing water, and buttressed gum and cypress trees throughout. The previous determination asserted a jurisdictional connection from this wetland to an unnamed tributary of the Pocolaligo River approximately 872’ southwest by means of an upland excavated agricultural ditch. Under current guidance from the EPA, outlined in the referenced memorandum above, discrete features such as this excavated ditch do not constitute a continuous surface connection thus rendering this wetland not subject to the Corps’ regulatory jurisdiction under Section 404 of the CWA.

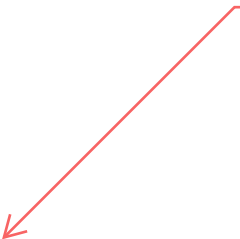
