MEMORANDUM FOR RECORD

SUBJECT: US Army Corps of Engineers (Corps) Pre-2015 Regulatory Regime Approved Jurisdictional Determination in Light of *Sackett v. EPA*, 143 S. Ct. 1322 (2023), ¹ SAC-2025-00529 (MFR 1 of 1)²

BACKGROUND. An Approved Jurisdictional Determination (AJD) is a Corps document stating the presence or absence of waters of the United States on a parcel or a written statement and map identifying the limits of waters of the United States on a parcel. AJDs are clearly designated appealable actions and will include a basis of JD with the document.³ AJDs are case-specific and are typically made in response to a request. AJDs are valid for a period of five years unless new information warrants revision of the determination before the expiration date or a District Engineer has identified, after public notice and comment, that specific geographic areas with rapidly changing environmental conditions merit re-verification on a more frequent basis.⁴ For the purposes of this AJD, we have relied on section 10 of the Rivers and Harbors Act of 1899 (RHA),⁵ the Clean Water Act (CWA) implementing regulations published by the Department of the Army in 1986 and amended in 1993 (references 2.a. and 2.b. respectively), the 2008 Rapanos-Carabell guidance (reference 2.c.), and other applicable guidance, relevant case law and longstanding practice, (collectively the pre-2015 regulatory regime), and the Sackett decision (reference 2.d.) in evaluating iurisdiction.

This Memorandum for Record (MFR) constitutes the basis of jurisdiction for a Corps AJD as defined in 33 CFR §331.2. The features addressed in this AJD were evaluated consistent with the definition of "waters of the United States" found in the pre-2015 regulatory regime and consistent with the Supreme Court's decision in *Sackett*. This AJD did not rely on the 2023 "Revised Definition of 'Waters of the United States," as

amended on 8 September 2023 (Amended 2023 Rule) because, as of the date of this decision, the Amended 2023 Rule is not applicable in this state due to litigation.

1. SUMMARY OF CONCLUSIONS.

a. The review area is comprised entirely of dry land (i.e., there are no waters such as streams, rivers, wetlands, lakes, ponds, tidal waters, ditches, and the like in the entire review area and there are no areas that have previously been determined to be jurisdictional under the Rivers and Harbors Act of 1899 in the review area).

3. REVIEW AREA.

- a. Project Area Size: 6.97 Acres
- b. Center Coordinates of Review Area: 33.7123°N, -78.8699°W
- c. Nearest City: Myrtle Beach
- d. County: Horry
- e. State: South Carolina

The 6.97 area of review is comprised of a partially cleared stand of loblolly pine and hardwood trees with a mowed understory. Approximately 41% of the review area is comprised of fill material placed on the site between 1939 and 1948 based on a review of historic aerials. This large upland lobe is evident on modern LiDAR imagery. The

remainder of the site is of slightly lower elevation mapped as Leon fine sand. Agent submitted soil samples confirm the presence of this hydric soil on site, yet during normal hydrological conditions no indicators of hydrology could be observed. A large excavation created between 1939 and 1948 for the purposes of draining an offsite wetland still exists onsite yet the wetland for which it was intended to drain has since been filled and replaced with commercial development. This excavation and a similar small excavation along the northwest linear extent of the area of review do not maintain any hydrologic connectivity to the water table nor any surface water feature. The area of review as depicted on the referenced map contains no aquatic features subject to the purview of the Corp.
