### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. B. ADDITIONAL COMMENTS TO SUPPORT JD: This site is a 0.779 acre parcel consisting of 0.32 acre of jurisdictional freshwater wetlands. The onsite wetland directly abuts an offsite tributary (perennial RPW) which flows directly into the downstream TNW (Waccamaw River). The onsite wetland is part of a larger wetland system that flows offsite to the west. The perennial RPW flows within the boundaries of the wetland system. The offsite tributary was previously observed on a site located downstream of the subject property and was determined to have perennial flow at least 90% of the year under normal climatic conditions (SAC# 2013-00914-3B, Letter dated October 1, 2014). A site visit was not conducted for this determination. After researching the best available information (i.e. aerial photos, topo maps, soil survey information, NWI maps, etc.) it was determined that the applicant's depiction of the onsite wetland is accurate. The wetland line depicted on the survey plat coincides with the soil types listed for the site and the wetland depictions on NWI maps.
