C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

conditions during a site visit conducted on April 9, 2016. Geomorphic indicators of perennial flow within the tributary include a firm sandy bottom free of vegetation and debris contained within a bed and bank system with the presence of an OHWM in the form of a clear natural line impressed upon the bank. The streams hydrologic indicators included an open channel with evenly distributed substrates and waters bars where leaves and debris are washed downstream by the constant flowing of water. The tributary is located adjacent to an offsite wetland and situated within hydric soils. Although the tributary receives runoff from the surrounding uplands the presence of Iron Oxidizing bacteria within the channel reveals that this feature is also intercepting ground water and draining the adjacent wetland. This feature continues off-site to the east where it appears to be natural and sinuous. Based on NWIs it bisects another wetland system before turning south then east again and passing underneath U.S. Highway 501 where it then drains into Mill Branch, which becomes Chinners Swamp, then Brunson Swamp and eventually drains into the Great Pee Dee River. This feature supports aquatic life such as small minnows and based on USGS topo maps appears to have been a naturally low lying drainage area that was manipulated through excavation for the purpose of straightening and/or deepening.

B. ADDITIONAL COMMENTS TO SUPPORT JD: : This form addresses a 12.78 acre tract located in Horry County. This Tract contains approximately 12.75 acres of upland and 461 linear feet of tributary that was determined to have flow at least 90% of the year under normal climactic conditions. Geomorphic indicators of perennial flow within the tributary include a firm sandy bottom free of vegetation and debris contained within a bed and bank system with the presence of an OHWM in the form of a clear natural line impressed upon the bank. The streams hydrologic indicators included an open channel with evenly distributed substrates and waters bars where leaves and debris are washed downstream by the constant flowing of water. The tributary is located adjacent to an offsite wetland and situated within hydric soils. Although the tributary receives runoff from the surrounding uplands the presence of Iron Oxidizing bacteria within the channel reveals that this feature is also intercepting ground water and draining the adjacent wetland. This feature continues off-site to the east where it appears to be natural and sinuous. Based on NWIs it bisects another wetland system before turning south then east again and passing underneath U.S. Highway 501 where it then drains into Mill Branch, which becomes Chinners Swamp, then Brunson Swamp and eventually drains into the Great Pee Dee River. This feature supports aquatic life such as small minnows and based on USGS topo maps appears to have been a naturally low lying drainage area that was manipulated through excavation for the purpose of straightening and/or deepening. One upland excavated non-jurisdictional ditch and one upland excavated storm water retention pond are located on-site. Based on a site visit conducted on 4/9/16, a review of aerial photographs, NWIs, USGS topographic survey information, and Horry County soil survey sheets these features were determined to be man-made, excavated out of uplands and to drain only uplands and are therefore non-jurisdictional.
