Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: The project review area contains 4 linear conveyances (farm ditches). The linear conveyances were excavated from uplands, drain only uplands, and displayed no OHW mark. They were approximately 2-3 feet deep and wide. The site visit for the original jurisdictional determination that included a larger review area than the approximate 71.3 acres for this jurisdictional determination was made on October 13, 2015, which was within 2 weeks of the historic rainfall event the area received, which was approximately 24" of rain. The linear conveyances were flowing at the time of the site visit, but the flow did not appear to be relatively permanent. For these reasons, the linear conveyances were determined to be non-jurisdictional and not subject to regulation under Section 404 of the Clean Water Act.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The approximate 71.3 acre project review area consists entirely of uplands. No wetlands or other waters of the U.S. are present within the project review area. However, four non-jurisdictional linear conveyances are present. The project review area is not subject to regulation under Section 404 of the CWA.
