the three criteria for a wetland; however, they were constructed in the uplands for the purpose of stormwater management. In addition, the pond and swale currently functions as stormwater features for the adjacent road. The pond has young trees growing in the basin, but the outfall structure and dam are still intact. The swale is stable and maintained as a grass area. Therefore, the stormwater pond and swale are NOT waters of the United States by definition 33 CFR 328.3 (waste treatment systems designed to meet the requirements of CWA).

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The 21.93 acre review area contains a 3 acre jurisdictional wetland. The 1.6 acre stormwater pond and 600 linear foot swale within the review area is not jurisdictional.
