C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: A desktop review was conducted on April 25, 2017. All of the necessary resources were reviewed to make the proper determination. The topographic map does not depict any Wetlands and/ or Waters of the United States on the Site. The Soils map depicts that the property is mapped with a Non-hydric Summerton loamy fine sand soil. The National Wetlands Inventory shows that the site is mapped as (U11) Uplands. In addition, the project area is located within the shoulder and right-of-way of an existing road. With the information gathered it was determined that the site does not include any Wetlands and/ or Waters of the United States and consist entirely of Uplands.
