C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

B. ADDITIONAL COMMENTS TO SUPPORT JD: All of the available resources were used to make the proper determination. The aerial, topograhic, soils data, and National Wetlands Inventory map were used to make the proper determination. The

topograhic map does not depict any Wetlands and/ or Waters of the United States. The soils map depicts that the site is mapped with a Hydric Rains Sandy Loam soil, however, the site is a small, developed single-family residential lot. The National Wetlands Inventory maps the site as (U11) Uplands. With the information gathered, it was determined that the site in question does not contain any Wetlands and/ or other Waters of the United States and consist entirely of Uplands.
