The project area consist of 0.247 acres of uplands in Sumter, SC. USGS topographic survey information depicted a residential urban area and is void of any blue line features or wetland symbols. NWI maps depicted the project area as residential. Based on a combination of the above listed resources the project area was determined to be void of aquatic resources.
