C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The area that the wetland traverses to get to Kingston Lake is mapped as Bladen, Pocomoke, and Megget soils on the NRCS Soil Survey. All three of these soil types are hydric. This same area is also mapped as palustrine wetlands on the National Wetlands Inventory (NWI) map.**

B. ADDITIONAL COMMENTS TO SUPPORT JD: This site consists of a 2.16 acre jurisdictional freshwater wetland that directly abuts Kingston Lake (perennial RPW upstream and becomes a TNW downstream). Standing water was observed throughout the wetland areas during both site visits. The soils observed onsite were a sandy loam that met the F3 Hydric Soils indicator. Vegetation present was mainly *Acer rubrum*-FAC, *Ilex glabra*- FACW, and *Pinus taeda*- FAC.

Topo maps depict a dashed blue line traversing the property and flowing to the northeast within the wetland system. The dashed blue line may become more of a defined tributary offsite; however, there was no evidence (bed and banks) of a defined tributary onsite.
